THE BEATIFICATION OF A BUSINESSMAN AND WHY IT IS IMPORTANT

The universal call to Saintity was reassured at Second Vatican Council and also at Apostolic Exhortation. Pope Francis's *Gaudete et Exultate*, based in evangelical mandate: "be perfect, as our celestial Father is". (Mt. 5,48)

Supporting models of Christian life is important to the evangelic mission of the Church. Saints spread a message through their conduct and example and the Church, through beatification or canonization, facilitates the dissemination of those actions.

Presenting examples is key to educational purposes. It can be very motivating to show that these behaviors are not only possible, but they have been experienced by concrete and credible people. Making these life examples known is positive for society, because "if the good is known, it is contagious" and thus many are encouraged to follow the path of holiness.

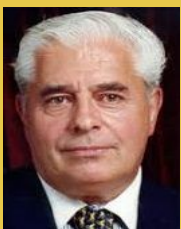
Thanks to the strong impulse of John Paul II, previous Pope, the path to sanctity of the laity was widely spread, and the possibility that Enrique could be declared a Saint began to be seen.

In 1996 the then Monsignor and after Cardinal Jorge Mejía made a public invitation for ACDE, the institution that Enrique founded, to promote the beatification cause and the path started to be very active at this respect.

With the compilation and the reading of large amount of material that Enrique Shaw wrote and through testimonies that were gathered, it was confirmed that Enrique was an example of life principles that should be known as a lay model.

As an model for entrepreneurs, Shaw demonstrates the possibility of passing through the much questioned life of a company, making profitability and excellence of business management coexist successfully with the principles of the Social Doctrine of the Church.

Even more, as the great businessman that he was, Enrique Shaw's work ethic shows that he sought from that subtle management to increase the benefits for the company and its people, obtaining an amazing commitment, respect and esteem from the personnel who enjoyed an optimal work environment.

GOD'S BUSINESSMAN

CAUSE OF CANONIZATION ENRIQUE SHAW

1962 – 27/08 Enrique Shaw dies at 41 years of age.

1967 – There is reliable data showing that the priest Paulino (Obra del Cardenal Ferrari) R.P. Francisco Rotger, began to collect information for an eventual opening of the cause, but died shortly after and it has not been possible to know how far he advanced. Nothing has been found in his community in Italy.

1984 – In the first edition of Ambrosio Romero Carranza's book, the author explicitly asks if Enrique's life plan was not aimed to achieve holiness (p. 217- 2nd Ed. - 1998). However, no initiative emerged at the time to request the opening of the cause.

1996 – For several years meetings were held to consider "what to do" in relation to Enrique, in March 1996 something new happened, when the question about "what to do" was reiterated in a meeting of "Encuentro". Bishop Iriarte suggested consulting to Cecilia Bunge of Shaw as a preliminary step, and with her agreement a series of meetings are initiated. Messrs. Hernando Campos Menéndez, Praxiteles Broussalis and Juan Cavo participate, then Ignacio Llorente, Recaredo Vázquez and Fernando Braconi. On the recommendation of Bishop Iriarte, a contact was made in the Curia with Bishop Rodhe, who advises in the early stages. Search of written testimonies began. The group worked prudently and with a very low profile. It begins to have written records of the proceedings. Among them was the conviction, because of the testimonies collected, that Enrique had been an extraordinary Christian and that he had levels of holiness within.

At the ACDE Lunch Forum (12/09/1996), Cardinal Jorge Mejía makes a surprise public invitation for the institution that Enrique founded to promote his Canonization cause. He had assisted Enrique as a friend and priest during the final period of his life. This is stated in the testimony that has been issued

for the opening of the cause. From that moment on, the "Enrique Shaw Commission" was created in ACDE.

1997 - 27/05, ACDE requests to be formally considered as Plaintiff in the cause, and the procedures for the "preliminary stage" to the Canonization process are initiated.

1999 - On 13/10, the Archbishop of Buenos Aires, S. E.R. Jorge Mario Cardinal Bergoglio approves the Postulator designated by ACDE, Lic. Juan Luis Mario Cavo. 16/11, an Ecclesiastical Tribunal "ne pereant probationes" is constituted for testimonial statements.

2000 - In January, Fr. Mario Poli presents the theological view of the written works of Enrique Shaw.

2001 - On 18/04, the Archbishop of Buenos Aires positively consulted the Bishops on the opportunity to initiate the Cause.

On 26/06, Jorge Mario Cardinal Bergoglio designate a Commission of Experts in History, to collect all the unpublished writings and historical documents, whether handwritten or already published, that are related to the Cause.

On 16/07, Cardinal Jorge Mario Bergoglio petitioned the "nihil obstat" to the Congregation for the Causes of Saints, in Rome. On 25/09, José Cardinal Saraiva Martins, Prefect of the Congregation for the Causes of Saints sent the "nihil obstat" for the Cause of Beatification and Canonization of the faithful Lay and family father Enrique Ernesto Shaw. This means that there are no obstacles in the Roman Dicasteries for the mentioned Cause.

2002 – July 15, after the death of Mr. Juan Cavo, ACDE appoints Lic. Fernán de Elizalde as Postulator of the Cause. His appointment receives the approval of the Archbishopric on August 28.

2004 – July 15, ACDE appoints Dr. Juan Gregorio Navarro Floria as Postulator for the Cause, and Lic. Fernán de Elizalde as Vice Postulator. Both designations receive the approval of the Archbishopric on July 21.

On November 29, S.E.R. Jorge Bergoglio appoints Fr. Dr. Alejandro Carlos Llorente as theologian expert to examine the published writings of the Servant of God.

2005 – May 30, Fr. Dr. Alejandro Carlos Llorente presents his report of censorship on the edited writings of the Servant of God before S.E.R., affirming "there is nothing in such writings contrary to faith or good customs".

On June 16, the Postulator for the Cause, Dr. Juan Gregorio Navarro Floria, formally presented to S. E.R. the formal opening of the Cause.

On August 25, the formal opening ceremony of the Cause is held at the Curia of Buenos Aires.

Dr. María Isabel De Ruschi Crespo is appointed as a member of the Commission of Experts in the History of the Cause.

2006 - Dr. Silvia Correale is appointed as postulator of the Cause in Rome.

2007- The definitive historical archive was enabled, in accordance with the established archive standards.

2008 - Prof. Mónica Cuccarese de Jonte and Lic.

Inés Gutiérrez Berisso de Marchionna join the Commission of Experts in the History of the Cause. 2009 to 2013 - The Historical Commission and the ACDE finalize the pending steps. On September 19, 2013, the Closing ceremony of the diocesan phase of the Cause of Canonization was held at the Argentine Catholic University.

2014 - - The documentation of the Cause is taken to Rome.

2015 - The Vatican Congregation for the Cause of Saints decrees the legal validity of the documentation received.

Monsignor Paul Pallath is appointed Rapporteur of the Cause.

2016 and 2017 - Monsignor Pallath delves into the story of Enrique Shaw and its historical context.

Several issues were overcome, due to the issuance of new legal norms regarding the organization of causes.

2018 - Final drafts of the Positio are approved.

Copies are printed and given to historians and theologians to work on.

2019 - The diocesan instruction documents of the alleged miracle of the Servant of God Enrique Shaw are presented in Rome.

“Union with God, with men, among us.”

Enrique, among many activities, became Deputy Director at Rigolleau SA glassworks. He participated in the Catholic Action and the Christian Family Movement. Together with other businessmen, he was a part of the organization of assistance to post-war Europe, promoted in 1946 by the Argentine Episcopate, responding to the call of Pope Pius XII. He aims to create an organization “for the businessman to be more Christian”.

With the incentive of Canon Cadjin he founded the current Christian Association of Business Leaders (ACDE) in 1952 and promote the entry to UNIAPAC (International Christian Union of Company Leaders) through intense evangelizing action in the country and Latin America.

He participated in congresses in 1957, gave lectures, edited publications, wrote his diary and some still unpublished manuscripts.

He became treasurer of the first Board of Directors in the Pontifical Catholic University of Argentina (UCA) and participate in the foundation of the Serra Club.

The Episcopal Delegate for the Causes of Saints and Castrense Bishop of Argentina, Bishop Santiago Olivera, was in charge of presiding over the ceremony at the Stella Maris Castrense Cathedral in Buenos Aires. After the oaths and the reading of the closing session carried out by the notary actuary, lawyer Carlos González; the original documentation on the investigation of an alleged miracle attributed to Shaw and its copies were signed and sealed in boxes.

Bishop Olivera gave two boxes to Juan Gregorio Navarro Floria, who presented them on May 2 to the Congregation for the Causes of Saints in Rome.

The event was attended by the members of the Castrense Ecclesiastical Tribunal in charge of the investigation of the alleged miracle: Bishop José Antonio Passarell as delegate judge and instructor; Father Juan Lisandro Scarabino as promoter of justice; Father Sergio Omar Fochesato as a medical expert; Cecilia Imbrogno, consecrated virgin, as deputy notary; and Carlos

González, lawyer, ambassador and general secretary of the Castrense Bishopric.

Archbishop Santiago Olivera expressed that, like Enrique Shaw, "there is a great need to say that there are countless good and holy men and women."

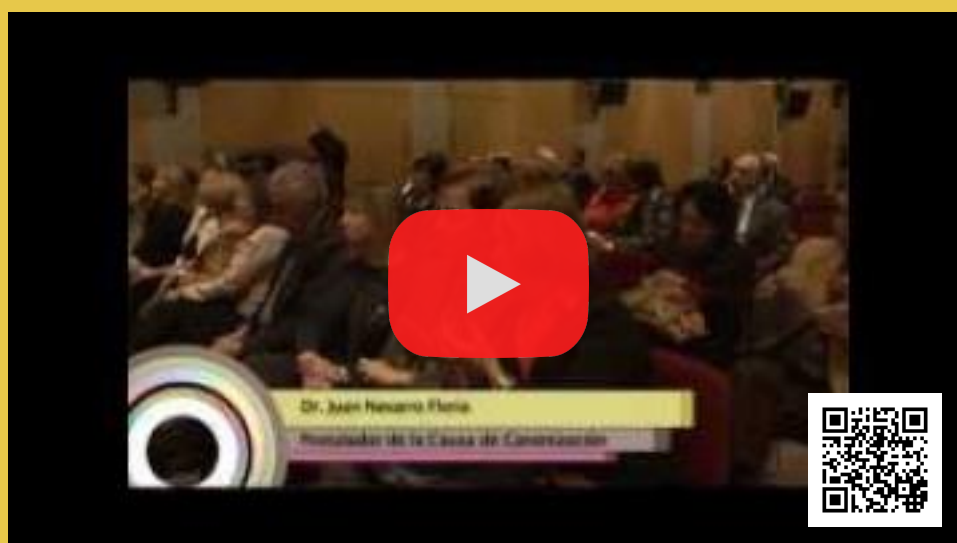

"The military profession is the only one that prepares our men to give their lives, to give their blood for the love of our brothers and the country. More than 500 participants were able to hear the testimony of Sara Shaw, Enrique's daughter, about her father's figure, with the President of Catholic Action Rafael Corso.

Laypeople, priests, bishops and religious from 37 dioceses throughout the country, from Jujuy to Tierra del Fuego, from Misiones to the Cordillera, took part in the meeting organized by the Department of Laity of the Argentine Episcopal Conference.

More than 35 movements and institutions, 15 pastorals of the Church, 5 religious orders and even social movements that were participating in the convocation for the first time.

Enrique Shaw was presented, together with Beatus Wenceslao Pedernera, as a lay model of the Second Vatican Council, at the National Meeting of the Laity that took place on July 8 in Buenos Aires.

5 LESSONS FROM AN ENTREPRENEUR IN CANONIZATION PROCESS



Transforming the World with Purpose

Perú - UNDEC Union of Catholic Businessmen of Peru and CENTRUM PUCP

CENTRUM PUCP brought together the most important business leaders from different countries on its campus, to share experiences about a very important topic: ethics and values in the business world.



The Dean of the Pontifical Catholic University of Peru, Dr. Carlos Garatea and the Vice Grand Chancellor of the PUCP and president of the Episcopal Conference of Peru, Monsignor Miguel Cabrejos, opened the day. Among other important speakers, Argentina was represented by Dra. Sara Critto de Eiras, who was invited by CENTRUM PUCP and the Undec - Union of Catholic Businessmen of Peru, to give testimony about the Entrepreneur Enrique Shaw:

At the end of his life in 1961, the majority shareholder of the Glasswork company ordered the dismissal of workers and Enrique, as managing director, said that if they fired even one, he would resign.

He persuaded them by showing the factual positive results of the company. Enrique was ill with cancer and his wife said that he was running out of retirement, that he was given into God's hands, he had a huge faith but she not that much. "Currently, a daughter of one of the workers who was going to be fired is grateful for this defense of the staff Enrique did, thanks to that action her family was able to have economic stability and support her education".

Enrique recognized the company as an economic reality that produces goods and services that people need, and it is also a human community of life and work where the people work for common objectives for several hours a day.

Enrique wrote: "Although a company works thanks to the search for a profit, the objective cannot be the maximum profit amount but the maximum of positive results in all dimensions" (SHAW, 2010: 79-101).

Enrique is a business leader, he believed "there are three duties that should be highlighted the most: service, progress and human ascension"

A) SERVICE: ESTEBAN WOCA AFFIRMS THAT ENRIQUE SOUGHT TO SERVE THE OTHERS, ALWAYS ASKING WHAT HE NEEDED AND LOOKING FOR HIS FAMILY. IN HIS PRESENCE THE EMPLOYEE FELT A DEEP PEACE, SECURITY AND WORKED AT EASE. ENRIQUE NOTED IN HIS FOLDER NO. 6: "HE WHO APPROACHES ANOTHER TO HAVE SOMETHING... TO GET SOMETHING OUT OF THE OTHER, WILL NEVER KNOW HOW TO HELP THEM TO BE MORE, WHICH IS THE MOST AUTHENTIC MANIFESTATION OF LOVE."

b) PROGRESS: By virtue of the biblical mandate to dominate the earth and the parable of the talents. Shaw took care of training with the latest technical advances to increase production, reduce fatigue of workers and save time in production activity. Thus, the employee Piccinini traveled to the USA on three occasions to train in laboratory area. In one of the plants the first fluorescent tubes were produced.

c) HUMAN ASCENSION: "The company leader must consider each of his human collaborators as a "possible" to whom facilitate the realization and help them find and extract the best that they have from themselves. The "climate" of the company must be such that it contributes to the rise of humans and offer them the best opportunities for they development through work. The company leader must facilitate all possible freedom so that each one is the owner of their acts and can express their personality" (Shaw, 2010: 23-24).



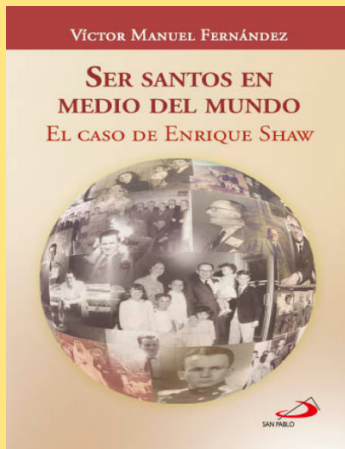

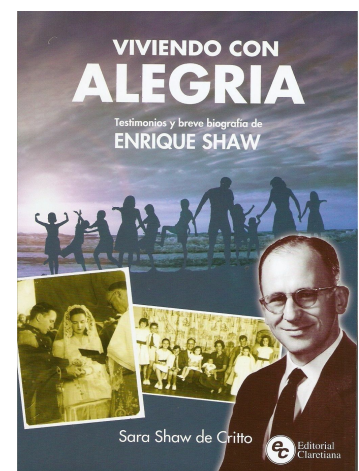

ENRIQUE ERNESTO SHAW

Nacido el 26 de febrero de 1921. Alumno del colegio de La Salle, fue oficial de la Armada Argentina. Se casó con Cecilia Bunge en 1943, y fueron padres de nueve hijos. En 1945 comenzó su activa y rica labor empresarial. Trabajó en distintas empresas, desempeñándose principalmente en las Cristalerías Rigolleau como Director Delegado. En 1947 ingresó a la Acción Católica, donde integró el Consejo Arquidiocesano de Hombres, la Junta Central y llegó a ser Presidente de la Asociación de Hombres. Participó en la formación del Movimiento Familiar Cristiano y del Serra Club. En 1952 fue fundador y primer presidente de la Asociación Cristiana de Dirigentes de Empresa (ACDE). También fundó la Casa del Libro Católico. Fue encarcelado en 1955 por pertenecer a la Acción Católica. Su aporte fue fundamental en la elaboración de la "Pastoral Colectiva sobre Promoción y Responsabilidad de los Trabajadores" de 1956. Participó también en la elaboración de la ley del Fondo Compensador de Asignaciones Familiares, promulgada en julio de 1957. Ese mismo año realizó estudios en Harvard. En 1958 integró el primer Consejo de Administración de la Universidad Católica Argentina. Hombre de gran sentimiento mariano, el común denominador de su vida fue el esfuerzo por responder cotidianamente a la misión que Dios le encomendara como laico, esposo, padre de familia y empresario. Murió en Buenos Aires el 27 de agosto de 1962. Sus restos descansan en el cementerio de la Recoleta
